Congressional Race Getting Crowded

The race to fill Rep. Henry Waxman's seat is filling up with candidates since the 20-term Congressman announced his retirement last week. Among the better known political figures who have announced their candidacies are former controller Wendy Greuel, who is endorsed by former Mayor Antonio Villaraigosa and Rep. Tony Cardenas; and State Senator Ted Lieu D-Torrance, who is endorsed by L.A. City Councilmembers Mike Bonin

and Paul Koretz. Others who are said to be considering a run for the seat include State Assemblyman Richard Bloom, who is the former Mayor of Santa Monica; former state legislator Sheila Keuhl; and former Santa Monica Mayor and City Councilman Bobby Shriver. Self-help author Marianne Williamson and television director Brent Roske have also announced their campaigns for the seat. The 33rd District, represented by Waxman since he was first elected in 1974, includes Calabasas, Agoura Hills, Malibu, Topanga and much of the Westside. The deadline to file nomination papers is March 7.

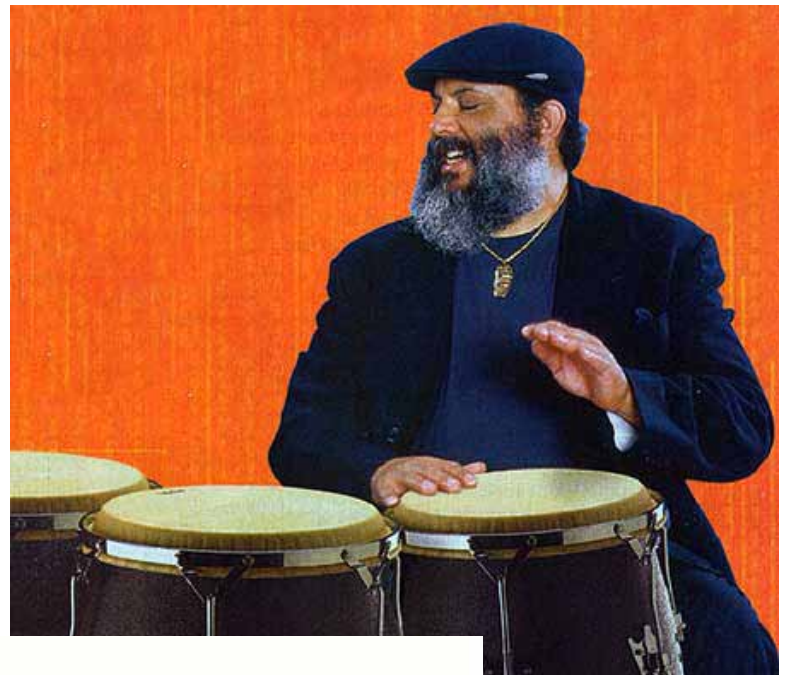
Calling All Maniacs! Take a Jazzy Journey Back to the Beatles And More Free Summer Concert in Park Schedule Announced

Republican **Susan Shelley**, right, who challenged Matt Dababneh for Bob Blumenfield's vacated seat in the November special election, has announced she will run for the seat again.

Shelley was 329 votes shy of winning the election for the 45th Assembly District.

Democrat Dababneh filled out the remainder of the term and will once again face Shelley in the June Primary Election. Shelley is endorsed by the Howard Jarvis Taxpayers Association and based most of her campaign on the fight to protect Proposition 13.

Dababneh said he will make "a clear distinction between my legislative agenda to improve our community and state and Ms. Shelley's political platform in the upcoming election."

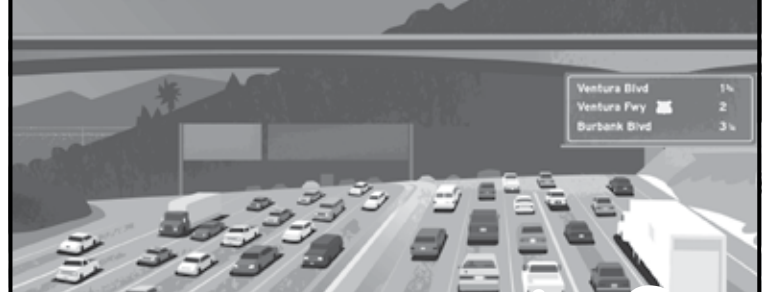

Is California drought caused by man-made "climate change"?

Last Sunday on TV talk-show Face the Nation, Denis McDonough suggested that the present California drought is the product of climate change. Denis McDonough is an important guy because he is the President's Chief of Staff. One presumes that he is citing the drought situation in support of the Administration's continual calls for government and private-industry action to confront man-made climate-change issues.

However, others are of the view that the drought, along with other recent events such as Hurricane Sandy and the massive snow storms elsewhere in the country are simply part of naturally-reoccurring cycles about which nothing much can or should be done. For example, concerning the drought, Bob Benjamin, who forecasts for the National Weather Service, says that the drought is the product of a weather ridge which over the millennia "comes and goes."

Even Climate Resolve, an activist environmental group, notes that the drought resembles a similar period in 1976-1977. Joseph Parfrey, Climate Resolve's executive director, says that over the centuries "the paleo-record shows the Southwest experienced multi-decadal droughts."

Obviously, this column cannot, and is not trying to, resolve the difference in viewpoints between Mr. McDonough and those who disagree with him. The disagreement does, however, serve to remind us that the once assumed universal consensus on man-made climate effects may have somewhat broken down. As a result, you can expect proposed climate-change legislation to continue to generate controversy as opposed to enjoining the smooth sailing such legislation has in the past enjoyed.

The six-state proposal is still moving forward

Recently in this column I reported on a proposed proposition to split California into six states. The state's legislative analyst has now issued a 16-page report saying that the proposal would be complicated to implement but not impossible.

The analyst's report indicates that some of the proposed new states would go up in per capita income and some would go down in this regard. Of the six states—Silicon Valley, North California, West California, South California, Central California and Jefferson—two (Silicon Valley and North California) would see their per capita income rise to \$63,288 from the current statewide level of \$46,477. This would occur because, per the report, the wealthiest parts of the present state are concentrated in the Bay Area. The remaining new states listed above would see their per capita income decrease.

Tim Draper, a Silicon Valley venture capitalist, is promoting the six-state idea; he and organizers of the proposed ballot proposition are presently trying to get sufficient signatures to place the proposition on the November ballot.

However, even were California voters to approve the measure, no state division could occur unless and until Congress gave its consent. Congress may not like the idea of 10 new Senators and a multiplicity of new Congressmen joining the body.

At the very least, the six-state idea, while with the analyst's tepid thumbs-up getting a new burst of energy, is a long, long way from reality.

The Fed, The Markets and Your Money

On January 29th, the Federal Reserve announced that it would be tapering its economic stimulus program by another \$10 billion per month, down to \$65 billion a month starting in February. The markets had an adverse reaction to the news, dropping more than 1% the same day the Fed made the announcement. Market volatility was an emerging theme throughout the month of January. The S&P was down 3.5% for the month, and the Dow was down more than 5%, making it the Dow's worst January since 2009.

2014 is already a year marked by uncertainties, prompting local financial advisor, Anthony Saccaro, ChFC®, president of Woodland Hills-based Providence Financial & Insurance Services, to offer perspective on how tapering and market volatility could impact the savings and investments of consumers.

"2013 was a record breaking year," said Saccaro. "But given the role of the Fed and its plans to continue tapering, this bull market could end up being a totally different animal in 2014." Saccaro offers insight on how tapering, market volatility and a possible market correction could impact the finances of area residents, and what they can do now to prepare.

The Fed's Tapering

Due to continued improvement of economic conditions, the Federal Reserve agreed to taper its mortgage-backed and Treasury securities bond-buying program known as QE3 by another \$10 billion per month. Janet Yellen, who officially took over as the chairman of the Federal Reserve on February 1st, is expected to stay on the same tapering course set by Bernanke, provided that the economy continues its upward swing. While not on a preset plan, if the tapering continues at the same pace, the bond-buying program could be completed by the end of the year.

"In theory, by not injecting billions of dollars into the economy each month, the dollar should become stronger, which is important for the stability of the economy and financial system," says Saccaro. "But there may be some temporary rough patches as QE3 draws to an end."

Saccaro advises consumers to be on the look out for a rise in interest rates, which can also have an effect on the bond market. As rates go up, bond prices decrease because new bonds become available that offer a higher yield at a lower cost. Bond fund holders may experience a loss



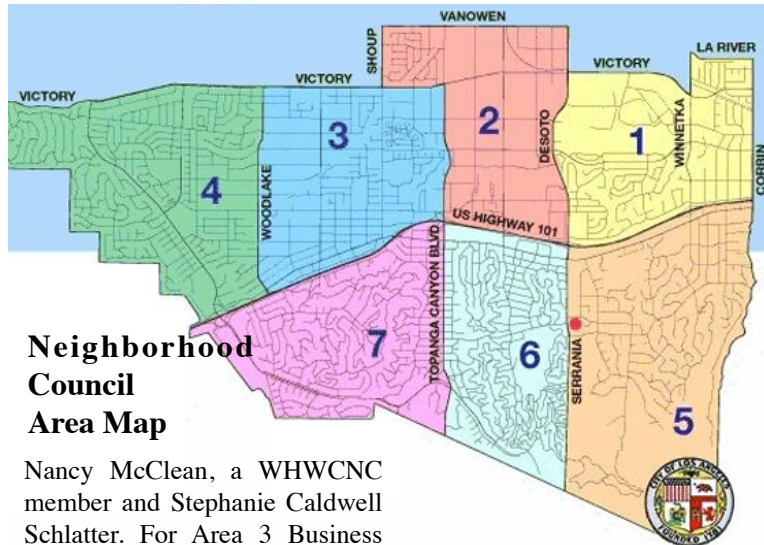

in principal as interest rates rise and bond prices drop.

Market Volatility

After a record-breaking performance in 2013, the market had a volatile start to the New Year. Some analysts cite the "January effect," predicting that a poorly performing January is an indicator of the market's direction for the entire year. Threats of emerging markets, contracting foreign economies and some lower than expected domestic manufacturing numbers, coupled with the Fed's announcement of additional tapering, has sent the market into a tailspin so far this year.

"If the markets continue on this volatile path, the gains from 2013 could end up having just been borrowed," says Saccaro.

Saccaro advises investors to make sure they're invested according to their timeline to retirement, and to consider diversifying in financial instruments not directly tied to market performance. Individual bonds, rather than bond funds, still offer a return if held to maturity. Some insurance products, such as

fixed annuities, offer returns higher than the rate of inflation without any correlation to market performance. This may be beneficial for those quickly approaching retirement.

A Potential Market Correction?

This is the 10th longest run in market history without a correction of more than 10 percent. The market continues to have a "taper tantrum" each time the Fed alludes to or makes an announcement about tapering its bond-buying program. Some analysts believe that the market set record highs in 2013 because of the amount of money that was injected into the economy each month, and if that ceases, record highs may too.

Since the Fed's December tapering announcement, a myriad of mixed economic news has also been released, from disappointing job growth to lower-than-expected home sales. These negative indicators have some asking if tapering started too soon.

"Without as much market-friendly stimulus going into the economy, and with the less-than-impressive January market performance, investors question

if a correction is on the horizon," says Saccaro.

Saccaro reminds us that investors were confident in 2000 and again in May of 2008 when the market closed at a record high just five months before it collapsed in October of that year. For market investors, Saccaro advises that they have a stop-loss strategy in place that would trigger if the market drops a pre-determined amount. This will help to shield them from any significant correction or crash like those seen in 2002 and 2008. Any sudden drop can cause considerable harm to portfolios and financial futures. This is especially true for those approaching retirement because investments have less time to make up for losses. It's important to know how much risk is acceptable to take on and how much you can afford to lose, and not to deviate from that plan.

Saccaro concludes, "Be smart about your savings and investments, and make sure you have a plan in place. 2014 could be a wild ride, but there's no way to know how wild until we actually experience it."

The Oscars are just around the corner and Universal's "Dallas Buyers Club" has been nominated for two best acting awards and for best picture of 2013. The storyline is based on a real Texas cowboy, Ron Woodroof, who when told he has less than a month to live, defies his medical advice and sets out to search the web for better ways to cure himself or at least prolong his life expectancy with non-approved

Las Virgenes Municipal Water District Conservation Measures in Effect for Drought

Citing current drought conditions as the worst in recorded history, Governor Edmund G. Brown, Jr. has proclaimed a "State of Emergency" for California and directed officials to take all necessary actions to prepare for the drought conditions. In addition, the California Department of Water Resources has reduced its allocation of water for State Water Project contractors to zero in 2014. Las Virgenes Municipal Water District (LVMWD) and its wholesale water provider, the Metropolitan Water District (MWD) of Southern California fully support the Governor's action, which calls for a voluntary 20% water use reduction.

David W. Pedersen, LVMWD's General Manager said, "We join the Governor and water agencies throughout the state in urging customers to reduce their water usage. We assure our customers that we can continue to provide water but are now relying upon stored supplies, which are presently adequate to meet our needs. However, if the drought continues into 2015, the water we save this year will be the water we rely upon next year. If LVMWD customers resume the conservation practices they used in 2009, we'll be fine. At that time, they reduced usage by more than 20 percent."

LVMWD has the following mandatory water restrictions now in effect:

1. Irrigation is prohibited between the hours of 10 a.m. and 5 p.m.
2. Irrigation water may not run off property into streets, gutters or onto adjacent properties.
3. Irrigation may not occur during periods of rain or in the 24 hours following rainfall of an inch or more.
4. The washing down of sidewalks, parking areas and driveways is not permitted, unless an approved water broom is used.
5. A trigger nozzle is required on hoses used for home car washing.

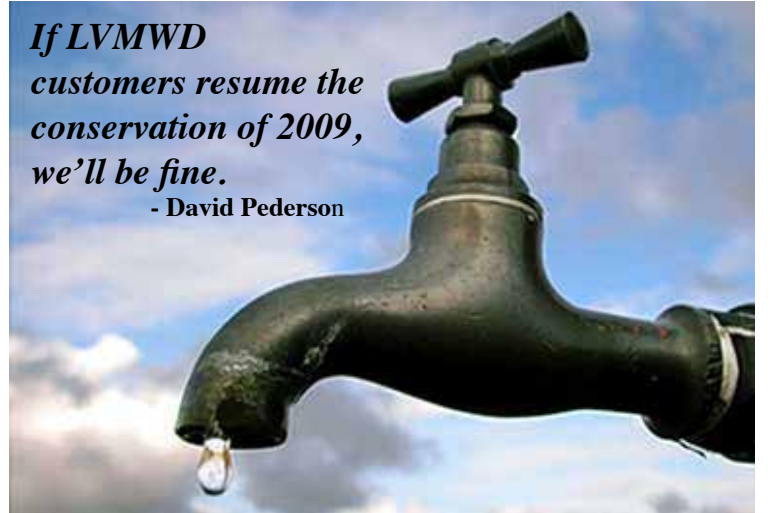
The following enforcement actions apply when a violation of the above restrictions is observed:

- First violation – notification letter;
- second violation - \$50;
- third violation - \$100;
- fourth violation - \$250;
- fifth violation – District may install a flow restriction device or terminate service.

Pedersen asked customers to reduce irrigation to no more than every other day and to be sure there is no runoff from irrigated area.

Personal Plea Urges Flu Shots

By Janey M. Rifkin
San Diego's Councilman Mark Kersey never expected to tweet the following message last weekend. It was a sad and urgent appeal:

"...my brother passed away from the HINI flu. PLEASE PLEASE get a flu shot. I'm not a doctor, but a flu shot might have saved him! My brother was 37; and left behind his wife Danielle, who was his childhood sweetheart, and four children, ages 17, 13, 7 and 3. He had a big heart and always wore a smile..."

The death toll attributed to influenza-related illness in California has reached 147 so far; including 17 people in Los Angeles County. It is unusually high, (just 14 people in the United States at the same point last year). These statistics are reminiscent of the disastrous flu season of 2009, when swine flu contributed to thousands of deaths around the world.

Typically, influenza strikes very old people or very young children more intensely than it affects young adults. But this year's predominant strain, HINI or swine flu, has behaved differently from past seasons, sickening otherwise healthy younger adults.

Dr. Jonathan Fielding, director of the County Department of Public Health, indicated that "We expect the number of deaths from the flu to increase, although there are early signs (slight decreases

in the number of flu-related visits to emergency rooms) that the situation may be leveling off a bit." However, he stressed the importance of getting the vaccine; and added that doses of the flu shot and nasal spray are "widely available."

Since influenza is always unpredictable, it is too early to know whether a slight decline will be sustained. "For anyone who hasn't been immunized, there's still time," Fielding said. And, as usual, the vaccine does not take effect for a couple of weeks.

Be aware the emphasis during this flu season is especially directed to young adults. The vaccination is painless, of course includes the HINI strain, and is available at doctor's offices and pharmacies.

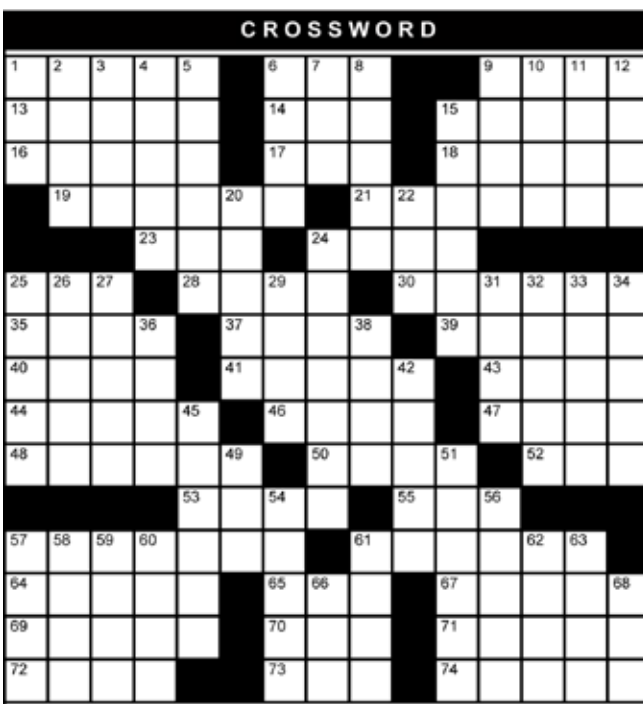
